

Abstracts are to be submitted exclusively via the EasyChair system. To make a submission, use the link: https://easychair.org/conferences/?conf = loto2018.

The submitted materials will undergo double-blind review. The organisers reserve the right to reject submissions that do not fit into the scope of the conference or the formatting requirements.

The formatting requirements are provided at p. 4. Abstracts should be prepared for blind review. This means that neither the abstract nor the file metadata may contain the authors' names, affiliations, or acknowledgements.

We accept abstracts in PDF format.

The accepted abstracts will be printed "as is" in the booklet to be distributed during the conference.

#### [empty line] Abstract Formatting Guidelines

**Introduction.** This document outlines the formatting requirements for submissions to "Logic Today: Developments and Perspectives". It can be used as a template for abstract preparation. Abstracts may be prepared using either Microsoft Word (or similar) or LATEX. The resulting file should be **in PDF format**. This document shows the formatting of the resulting PDF. Authors using Word-type text processors may ignore the section "Formatting with LATEX" (see next page).

Abstract formatting. Please mind the following formatting requirements.

- Margins: 2.5 cm; leave an empty line before the title
- Spacing after the title and between sections: 0.5 cm. Do not insert extra space between paragraphs
- Times New Roman font, 12pt
- Single spacing
- Text alignment: justify
- Avoid footnotes and page numbering
- The abstract should be no longer than two pages, including references

# Do not insert authors' names, affiliations or acknowledgements in the abstract!

Numbered formulae and examples:

$$\forall x (P(x) \to Q(x)) \tag{1}$$

Reference to a formula: (1).

References to bibliography items: [1], [2, 3].

Formatting with  $L^{AT}EX$ . If you are preparing your abstract using  $L^{AT}EX$ , insert the following into the preamble:

\documentclass[12pt,a4paper]{article}
\usepackage[margin=2.5cm]{geometry} margins
\pagestyle{empty} page numbering off
\usepackage{tempora} Times-like font
\addto\captionsenglish{\renewcommand{\refname}{\normalsize{References}}}
```

Use \paragraph for sections. Do not use \section, \subsection, etc. To produce a numbered formula (like (1) above; requires the amsmath package):

\begin{equation}
\forall x (P(x) \rightarrow Q(x))
\end{equation}
```
